# Hotels


OHA has a raft of new exhibits for young and old. First is "An Accommodating Legacy, The History of Hotels in Down-

town Syracuse.' This provides a chronological overview of the development of "hotels" in Syracuse's downtown. from the community's origins in 1806 with the opening of Bogardus' Tayern to

the most recent proposal for a new convention center hotel. The exhibit explores the various forces and trends that have shaped the changing nature of downtown hotels. It consists of interpretive text panels, enlargements of historic photographs from the OHA collections, original documents and artifacts. It includes a video with stories of interesting personalities associated with local hotels, provided courtesy of WCNY.

Examples of some items displayed include: the c1900 metal registration "desk" from the Vanderbilt House, 19th century menus from hotel banquets, a dinner plate from the Hotel Onondaga's Roof Garden, a painting that once hung over the famous Yates Hotel bar, original architectural drawings of the Onondaga Hotel, a c1960 photograph of the Mohawk Manor, the genesis of today's Genesee Grande, a registration card signed by silent movie era child star Jackie Coogan,

### FROM THE DIRECTOR'S DESK

We all know that OHA aspires to be "the leading regional destination for inspiration" as articulated in the Mission Statement adopted in 2004. There is mounting evidence that this is not just an appiration. Offering testimony to the quality of OHA's efforts, we have been the recipient of six prestigious awards at the national, state, peer and local community levels citing our archives and collection, our exhibit interpretations, our programming and our educational outreach into the community.

We began in April 2004 with our Underground Railroad exhibit. "Freedom Bound" being honored for excellence by the Upstate History Alliance. They presented us with a 2004 Upstate History Avand Of Merit! Comparabations to Dennis Connors and all the rest of the staff for a job well done. This is an important award that was announced in April at the UHA/MANNY Annual Meeting in NYC. OHA was in the spotlight for superior professional practice as well used to the superior of the superior professional practice as well as a truly innovative production. The award cited "the institution's progressive mission, clear goals, significant topic and attractive exhibiti." Our community involvement was also noticed. This is significant peer recognition.

Lightning artiles twice! Our Cataloguing Project was also honoved for excellence by the Upstate History Alliance: They awarded us a second 2004 Upstate History Award of Merit! The project and work by former. Archivist and Research Center Manager, Pall McCray as well as Mike Martin and Sara H. Name who assisted Phil were cited for superior professional practice. This was the second Award of Merit given out by UHA! This again represents peer recognition.

In November OHA was awarded the 2004 Annual Archives Award for Program Excellence in a Historical Records Repository by the NYS Education Department. This award is presented by the Board of Regents and the State Archives annually to an organization that "exemplifies excellence in an archival program". This is extremely prestigious statewide recognition. We were commended for processing our entire collection of archival records and making them available via online catalogues of the NYS Library (Excelsior) and the Library of Congress. It was also noted that OHA has more accessible records than any other repository in the state. The award made note of OHA's commitment to outreach as demonstrated in our exhibitions, workshops and children's activities. The citation concludes by citing OHA as a "model and inspiration for other repositories in the state."


OHA was awarded designation by the National Park Service as an official site on the Federal agency's Underground Railroad Network to Freedom system. We were cited as "making a significant contribution to the understanding of the Underground Railroad in American History". We can now display the National Underground Railroad Network to Freedom logo and are listed on the NPS Network to Freedom website. This is national recognition of the quality of our efforts.

Based on our receipt of these awards and our growing impact in the community, OHA was named an Economic Champion by the Greater Syracuse Chamber of Commerce. This provides good evidence of local community recognition of our value.

And finally, OHA has been named a Heritage New York Underground Railroad Regional Interpretive Center which includes the award of a \$50,000 grant. This will allow us to broaden the scope of our exhibits and programming and create brochures. We will also be the recipient of NYS tourism promotion.

2004 and 2005 have been banner years for OHA and we can truly call ourselves "An Award Winning Institution!"







# PRINCE HENRY OF PRUSSIA

The city was waiting, eagerly anticipating the arrival of Henry, crown prince of Prussia, and his wife Princess Alice, who were touring the USA. They were to arrive in Syracuse on Wednesday evening, 5 March 1902 and spend about 10 minutes in the city. Mayor Jay B. Kline named 125 notable Syracusans and local businessmen, several with German surnames, to a committee to plan and receive Henry and Alice.

The Committee of Arrangements met on Monday, 3 March to discuss the details of the program. The die for the handsome gold medallion to be presented to Prince Henry had been obtained from NYC. The medallion was enclosed in a silver case bearing the coats of arms of the United States and Germany. The Committee of Souvenir also struck facsimiles of the gold medallion in bronze and aluminum to be sold to help defray the cost of the medallion and reception. Only 125 bronze medallions would be struck; these were reserved exclusively for members of the Committee of Reception at a cost of \$5.00 each.

The program was grandiose and impressive for the short time allowed for the reception. A New York Central train carrying the royal couple and their entourage would stop in front of City Hall at 10:50pm. It would depart no later than 11pm. The great citizenry of Syracuse would greet the train with a 21-gun salute, followed by Goettel's band playing a lively German tune. Mayor Kline and Committee Chairman Charles Andrews would board the rear platform and greet Henry and Alice with a brief proclamation. These gentlemen would then present the gold medallion to Henry who would acknowledge the gift. After the speechifying the Liederkrantz Society choir would sing. At the conclusion of the presentations, and as the train departed from downtown, the Saengerbund would sing Heute Scheide Ich, a patriotic composition.

The Committee expected large crowds. To prevent the throng from getting too close to the train, city police officers and militia were to cordon off an area they called the "hollow square." They would create a space large enough for the train's rear platform to be inside the center. Only a select few participating in the program would be allowed inside the hollow square and no one else. Nor would



officials allow the crowds to gather close to the train at any point during its brief stay in Syracuse. Jacob Amos, former mayor, had spoken to his connections with the NYC railroad and thought he could secure a few additional moments for the reception.

The Evening Herald anticipated the event with a description of the royal party's itinerary, the text of speeches and a statement from US Ambassador to Germany, Andrew White: "Never Was a Noble Purpose More Nobly Accomplished Than By Prince Henry's Mission." The committee was ready for the arrival of Prince Henry and Princess Alice, or so they thought!

Fifteen thousand people poured into downtown Syracuse looking for an opportunity to behold Henry and Alice. The area was illuminated with extra lights. An electric sign attached to City Hall glared "Syracuse Bids You Welcome." The police and militia units formed the hollow square, determined to keep the peace. At 10:51pm a whistle blasted, signifying the couple's arrival. Ecstatic citizens wanting to get a closer look of the royal couple ran from hotels, business blocks, and side streets. Police and soldiers began to grapple with people trying to penetrate the area. They tried to stave off the crowd, to no avail. As the train pulled into position in the hollow square at 10:59pm, passengers on the royal train watched as security forces battled with the assembled swarm.

The prince emerged from the train car, observed the chaotic melee before him, smiled at the brawling crowd, and immediately retreated back inside the train, followed by Mayor Kline and other city officials. The mayor presented the gold medallion to Prince Henry and made his short proclamation. Prince Henry said, "I have noticed the great demonstration and it touches me deeply that there should be such a gathering to do me welcome. I wish you would convey to the people of Syracuse my appreciation." Mayor Kline, Charles Andrews and Prince Henry emerged from the rear of the train car. The crowd burst forth in massive cheers as they saw the prince. Henry remained on the rear platform, saluting the crowd as the train left Syracuse.

The legacy of this story lives on at OHA's museum. The museum now owns one of these bronze medallions, recently donated by Robert Hudson of Palatka, Florida. Mr. Hudson is a descendent of a few notable CNY families. We gratefully accepted the medallion and added it to the treasury of other significant material culture that helps us interpret our abundant community history.
